



# RE: Notice of Tariff Surcharge Reduction

Valued Allegion Customer,

As previously communicated, we have continued to monitor market conditions related to tariffs affecting the Americas region. As we continue our efforts to mitigate the impact to you as well as respond to new developments, we are pleased to announce a reduction to our current tariff surcharge rates. The new rates below will supersede previous tariff surcharges established on Monday, April 28, 2025.

**The following tariff surcharges are effective Tuesday, May 20, 2025:**

1. Allegion will apply a tariff surcharge on all new orders received on or after the effective date as follows:

### **Locks & Access Solutions**

- Schlage & Falcon Commercial Locks: 3.5%
- Dexter Commercial Locks: 5.0%
- Schlage Commercial Electronics (Elocks, Credentials/Readers): 3.5%
- Schlage ECS (Maglocks & Power Supplies): 5.0%
- Locknetics: 5.0%

### **Exits**

- Von Duprin & Falcon Exits: 3.5%
- Dexter Exits: 5.0%
- Von Duprin Electronic Accessories (6000 series, Power Supplies): 5.0%

### **Accessories**

- GJ, Zero: 3.5%
- Ives, SOSS: 5.0%
- Trimco: 0.0% (Previously announced 4.5% list price effective 4/1/2025)

### **Door Controls**

- LCN Cast Iron: 3.5%
- LCN & Falcon Auto Operators: 3.5%
- LCN 4050: 5.0%
- LCN, Falcon & Dexter Aluminum: 5.0%

- LCN Magnets: 5.0%

## **Residential**

- Schlage Mechanical/Electronics: 3.5%
- J Series & Dexter: 5.0%
- Builders Hardware: 5.0%

**AD Systems:** 3.5% (for all orders that have not been released for production on or before 5/20/2025)

2. The reduced tariff surcharges apply to all order types including project quotes and buy program orders and will supersede (not incremental to) prior tariff surcharges.

3. All orders received prior to May 20, 2025, will maintain the surcharge amount listed on the sales order acknowledgement. All new purchase orders acknowledged on or after May 20, 2025 will include the above surcharge amounts.
